OFFICIAL RULES

NO PURCHASE NECESSARY. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. VOID WHERE PROHIBITED BY LAW.

1. PROMOTION DESCRIPTION: 2024 Howl-O-Ween Household Giveaway – Fareway – Capital City Fruit Sweepstakes

("Sweepstakes") begins on **October 17th, 2024**, at 12:00:00 AM Central Time ("CT") and ends on **October 31st, 2024** at 11:59:59 PM (CT) ("Promotion Period"). Entry in the Sweepstakes does not constitute entry into any other promotion, contest, or sweepstakes. By participating in the Sweepstakes, each entrant unconditionally accepts and agrees to comply with, abide by, and be bound by these Official Rules and the decisions of Fareway and Capital City Fruit ("Sponsors"), which shall be final and binding in all respects.

2. ELIGIBILITY: Open only to legal U.S. residents living within 50 miles of a Fareway store who are at least eighteen (18) years old (or the age of majority in their state of legal residence, whichever is older) at the time of entry. Employees of Fareway, Capital City Fruit, or of their respective parent companies, affiliates, subsidiaries, prize suppliers, advertising and promotion agencies ("Promotion Entities") and wholesalers, suppliers, distributors and retailers of alcoholic beverage licensees (collectively, "Licensees") and immediate family members (spouses, parents, children, siblings, and their spouses) and/or individuals living in the same household as employees of Promotion Entities and Licensees are not eligible to participate. **Void where prohibited by law.**

3. HOW TO ENTER:

ONLINE: To enter online, go to <http://www.fareway.com> ("Website") and follow the online instructions to register and complete your entry into the Sweepstakes. Online registration and entry are free. Online entries must be completed by 11:59:59 PM (CT) on 10/31/24.

BY MAIL: To enter by mail, handprint in ink on a 3" x 5" card, your full name, complete home address and zip code, daytime telephone number including area code, date of birth, and e-mail address (if any). No metered mail will be accepted. All mail-in entries must be postmarked by 10/31/24 and received by 11/6/24. No copies, facsimiles or mechanical reproductions will be accepted. Sponsor assumes no responsibility for lost, late, incomplete, stolen, misdirected, illegible or postage due entries or mail. Limit one (1) entry per outer stamped mailing envelope.

All entries become the property of Sponsor and will not be returned. Limit one (1) entry per email address/per person, per Day – regardless of method of entry. For purposes of this Sweepstakes, a “Day” is defined as any consecutive twenty-four (24) hour time period during the Promotion Period starting at 12:00:00 AM (CT) and ending at 11:59:59 PM (CT). In the event of a dispute regarding any entry, such entry will be deemed to have been submitted by the Authorized Account Holder of the email address submitted at the time of entry, provided that person meets all eligibility requirements set forth in these Official Rules. “Authorized Account Holder” means the natural person who is assigned to an email address by an Internet access provider, online service provider, or other organization that is responsible for assigning e-mail addresses for the domain associated with the submitted e-mail address. Entrants may not participate with multiple e-mail addresses, nor may entrants use any device or artifice to enter multiple times per Day or as multiple entrants. Any entrant who attempts to enter with multiple e-mail addresses per Day, under multiple identities or uses any other device or artifice to enter multiple times per Day will be disqualified from participation in the Sweepstakes and all entries submitted by that entrant will be void. Only fully completed entries are eligible. Proof of submission will not be deemed to be proof of receipt by Sponsor. Sponsor is not responsible for any change of mailing address, email address, and/or telephone number of entrants.

4. RANDOM DRAWING:

The winners will be selected in a random drawing to be held on or about 11/6/24 from among all eligible entries received by Sponsor or its designee, whose decisions are final and binding. Winners will be notified by phone, mail and/or email at Sponsor’s discretion using contact information provided at the time of entry. Sponsor is not responsible for any change of mailing address, email address, and/or

telephone number of any entrant. Sponsor shall have no liability for any winner notification that is lost, intercepted, or not received by the potential winners for any reason. If, despite reasonable efforts, any of the potential winners do not respond within seventy-two (72) hours of the first notification attempt, or if the prize or prize notification is returned as unclaimed or undeliverable to any of the potential winners, such that the potential winners will forfeit his or her prize and an alternate winner(s) may be selected. Sponsor, in its sole discretion, will attempt to contact up to three (3) potential winners of a prize in accordance with the above procedure, after which the prize in question may go unawarded if it remains unclaimed. If any potential prize winner is found to be ineligible, or if he or she has not complied with these Official Rules or declines the prize for any reason prior to award, such potential prize winner will be disqualified, and an alternate prize winner may be selected. Where applicable, winners will receive a 1099 tax form for the actual retail value of the prize won.

Potential Prize winner will be required to sign and return a notarized Affidavit of Eligibility/Liability Release including the recording of their social security number (for tax reporting purposes – as required by law) and, where permitted by law, Publicity Release within ten (10) days after first notification attempt.
